What are cookies?

Cookies are a small text files that are stored in your web browser that allows DK Maritime or a third party to recognize you.

Cookies can be used to collect, store and share bits of information about your activities across websites, including on DK Maritime's website.

Cookies might be used for the following purposes:

- To enable certain functions
- To provide analytics
- To store your preferences
- To enable ad delivery and behavioral advertising

DK Maritime uses both session cookies and persistent cookies.

A session cookie is used to identify a particular visit to our Website. These cookies expire after a short time, or when you close your web browser after using our Website. We use these cookies to identify you during a single browsing session, such as when you log into our Website.

A persistent cookie will remain on your devices for a set period of time specified in the cookie. We use these cookies where we need to identify you over a longer period of time. For example, we would use a persistent cookie if you asked that we keep you signed in.

How do third parties use cookies on the DK Maritime Website?

Third party companies like analytics companies and ad networks generally use cookies to collect user information on an anonymous basis. They may use that information to build a profile of your activities on the DK Maritime Website and other websites that you've visited.

Personal data

In general

Personal data are all kinds of information that somehow connects to you.When you are using our website, we collect and treat this information. For example, it happens if you use our contact formula. We typically collect and process the following types of information: A unique ID and technical information about your computer, tablet or mobile phone, your IP number, geographic location, and which pages you click (interests). To the extent that you explicitly consent to this and even enter the information, you will also be treated: Name, phone number, email and address.

Safety

We have taken technical and organizational measures against the fact that your information is accidentally or illegally deleted, published, lost, impaired or comes to the knowledge of a person, misused or otherwise treated in violation of the law.

Purpose

The information is used to identify you as a user and show you the ads that are most likely to be relevant to you and to provide the services you have requested, such as to send an e-mail through the contact formula. In addition, we use the information to optimize our services and content.

Period of storage

The information is kept for the time allowed by law and we delete them when they are no longer necessary. The period depends on the nature of the information and the background for storage. Therefore, it is not possible to specify a general timeframe for when information is deleted.

Disclosure of information

Data about your use of the website, which ads you receive and, if any, click on, geographic location, gender and age segment, etc. be disclosed to third parties to the extent that this information is known. You can see which third parties are in the "Cookies" section above. The information is used to target advertising. In addition, we use a number of third parties to store and process data. These only deal with information on our behalf and may not be used for their own purposes. Disclosure of personal information such as name and e-mail, etc. will only happen if you consent to it. We only use computer users in the EU or in countries that can provide your information with adequate protection.
